

LIMITED LIFETIME WARRANTY

BearB Products (BBP) warrants to the original consumer purchaser (“you” or “your”) that each new Stellar Span railing product (the “Product”) will be free from defects in materials and workmanship for as long as you own the Product, beginning on the date of purchase. The warranty period begins on the documented date of purchase of the Product. This warranty is extended solely to you and for your benefit and is not transferable. The warranty period for a repaired or replaced Product will be the remaining time on the warranty of the originally purchased Product or 30 days, whichever is greater.

The warranty is limited exclusively to parts. BBP does not warrant the workmanship of the installer, whether professional or otherwise.

If you discover a material defect during the warranty period and BBP agrees that the defect exists, BBP will, at its sole discretion, provide you at no charge with replacement parts for the defective parts. BBP may require adequate documentation proving purchase before issuing a replacement part or Product.
